

# **PIAA Junior Officials Program**

Goal-assist in the recruitment of officials

# **Key Points:**

### **For Chapters**

- 16 and 17-year-olds can officiate ninth grade and below contests.
- Chapters must employ a Mentorship Program which must be strong and active.
- Assignors must be aware of Junior Officials and assign them with their mentor.
- Social media access for these groups should be considered.
- Chapters must make these Junior Officials feel welcome at meetings and engage them in conversation during these meetings.
- Junior Official must be given opportunities to work immediately
- Attendance at meetings required.
- Junior Officials are not volunteers and need standard remuneration for contests worked.
- Use social media to publicize events/clinics for prospective officials.
- Conduct separate Junior Official meetings prior to regularly scheduled chapter meetings.
- Create an Officials' Closet for new officials to get uniforms, etc. early in their career.

# **For Current Officials**

- Actively seek out prospective officials.
- Engage Junior Officials in conversations on officiating.
- Become a mentor and work contests with your mentee and provide person to person feedback before, during and after contest.
- Check in periodically with the Junior Official during the week and season.
- Provide video resources to the Junior Official for them to view at their pace.

### **For Schools**

- Game management must be especially alert and active when a Junior Official is working.
- Must actively reach out to prospective officials (students within the school).
- Create/sponsor a club or activity within the school regarding officiating.
  Use teacher/official as club advisor.
- Provide notoriety to students engaged in the program, congratulate the students in your school.
- Pay standard game fees to Junior Officials.

## **Coaches' Responsibilities**

- Encourage students/players to become officials.
- Treat all officials with respect.
- Leave the adversarial position at the door.
- Provide encouraging feedback to Junior Official through the chapter.

## Why Become an Official?

- Hang out with friends.
- Stay fit.
- Opportunities for all sports.
- Make extra money.
- Learn life skills.
- Stay connected to sports by learning rules, assists those who want to coach.

# **Roadblocks to the Program**

- Lack of interest by students and administrators.
- Continued poor treatment of Junior Officials.
- Conflicts with those playing the sport.
- Lack of contests to work.
- Alienation by chapter members.
- Startup costs for Junior Officials.

## **Additional information**

- Registration fees are waived by PIAA for Junior Officials.
- Can officiate at current school district thereby eliminating transportation concerns.
- Junior Officials can graduate to an active, registered PIAA official at age 18 or when they graduate from high school after submitting clearances.
- The Chapter should consider conducting an exit interview for those leaving officiating.
- Conflict of Interest should not be an issue with lower-level contests.
- Officially Sports, "The Official Licensed Supplier of the PIAA" will provide uniforms at reduced costs.

## **How Will the Program Get Started?**

- 1. PIAA will make formal announcement via news release on social media platforms and with news media directly **DONE**
- PIAA members schools through athletic departments will be provided details regarding the program and how prospective officials can apply -DONE
- 3. All prospective applications will be forwarded to the PIAA Officials' Department(khill@piaa.org) for review and creation of PIAA profile.
- 4. Direct contact made by PIAA staff with applicant via email and telephone regarding the application **DONE**
- Notice provided to chosen chapter secretary regarding Junior Official joining their chapter - **DONE**
- Affected chapter secretary will immediately notify Chapter Mentorship Coordinator to assign mentor - DONE
- 7. Mentor shall reach out to Junior Official to introduce themselves **DONE**

- 8. Assignors should also make direct telephone contact with the Junior Official to advise them of the assignment process.
- 9. At season's end the chapter Mentorship Coordinator must personally interview the Junior Official to gather feedback about the season and provide any further guidance for the following season.
- 10. Chapter Presidents are encouraged to provide a written summary to PIAA Officials Department regarding the number of Junior Officials in the chapter and an evaluation of the program from the chapter's point of view.
