



Selectivity of First-Year Classes: Median SAT and Average High School GPA, Fall 2016 – Fall 2020




Percent Admitted




FY Enrollment by State (Excluding International Students) Fall 2016 – Fall 2020



First-Year Undergraduate Enrollment by Region, Fall 2020




First to Second Year Retention Rates Entering First-Year Cohorts Fall 2010 – Fall 2019



Four-Year and Six-Year Graduation Rates Entering First-Year Cohorts Fall 2008 – Fall 2014




Four Year Graduation Rates by Race/Ethnicity Entering First-Year Cohorts Fall 2012-Fall 2014





Six Year Graduation Rates by Race/Ethnicity Entering First-Year Cohorts Fall 2012-Fall 2014





Percent of Students Within Racial/Ethnic Group that Left Before Graduating Entering First-Year Cohorts Fall 2012-Fall 2014





Four Year Graduation Rates by Low-Income Status Entering First-Year Cohorts Fall 2012-Fall 2014






