

# *NEW Tribal and Dual Language Program Grant Opportunities*

We have additional grant funds to offer another round of 2-year grant opportunities to support Tribal language and dual language programs. The purpose of these grants is to provide seed funds to plan and build capacity for effective, sustainable P-12 Tribal language and dual language programs. Grant opportunities:

- **2-Year Tribal Language Program Grant** | \$60,000 grant | up to 18 grants will be awarded for this amount to be spent over the 2021-23 fiscal years.
- **2-Year Dual Language Program Grant** | \$35,000 – \$60,000 grant | 3 – 5 grants to be spent over the 2021-23 fiscal years.

## **Possible Uses of Funds**

State-Tribal Education Compact schools, school districts, and public charter schools are invited to apply for both grant programs. Funds can be used for key start-up costs such as planning the language program and developing a P–12 master plan, professional learning for educators and administrators supporting the language program, bilingual educator development and recruitment, procurement or development of curricula in the partner language, and stipends for Elders to preserve and share Tribal languages with educators.
