## CONFIDENTIALITY AND WAIVER AGREEMENT

The undersigned Interested Buyer ("Buyer") is being provided detailed property information related to *Project Verde* ("Property") located in the states of Arkansas, Louisiana, Alabama, Virginia and Florida and issued by *LandVest*, *Inc.* ("Broker") on behalf of *Conservation Resources*, *LLC* (collectively "Seller").
