I have been unflinchingly clear in my stance on holding law enforcement and others accountable. I will create an independent prosecutorial unit that will investigate all police use of force and misconduct cases, as well as maintain an up-to-date Brady and no-call list violations. This group will answer directly to me and will be given the opportunities and resources to hold unethical and violent police officers accountable for their actions.

The MCAO has an office culture that has led to high turnover and excessive overcharging in some of the most prominent cases. As County Attorney, I will come in with a new set of standards and ethical guidelines to ensure the office is pursuing justice in each and every case. Prosecutors that do not adhere to the new guidelines will be placed under review, reported to the bar consistent with the Rules of Professional Conduct, and if there's no improvement they will be let go.

I plan on creating a conviction integrity unit to ensure the MCAO is not convicting innocent individuals and that the office is thorough and accountable in all cases.

I've spent the last two years speaking with directly impacted people in Arizona. While I realize that Arizonans are deeply divided on this issue, I continually hear from directly impacted families who believe that the death penalty is not real justice and does not provide true accountability for harm. When *Shinn v. Ramirez* was decided—a case that allows Arizona to execute people even when there is proof of actual innocence—it forced me to confront what these families have been saying for a long time. This is not justice.

Because of the racial disparities in who faces the death penalty, because of the record of botched executions, because of the high cost to the taxpayers, because of the multiple death penalty exonerations in Arizona's history, and because of the advocacy of directly impacted people who want to see real accountability replace vengeance in our legal system, I believe that the county attorney should not seek the death penalty.
