## **Accelerated Program Application**

Policy: To qualify to begin an approved Accelerated Program, an undergraduate bachelor's degree-seeking student must:

- 1. Earn at least 60 credits.
- 2. Transfer students must have earned a minimum of 12 credits from California University.
- 3. Possess and maintain an overall California University grade point average of 3.00 or better in both Graduate and Undergraduate coursework.
- 4. Secure approval from the Graduate Program Coordinator and the Dean of Graduate Studies and Research.
- 5. Complete the application process for graduate school acceptance. Student must be accepted provisionally to selected program.
- 6. Understand that all credits taken while part of the Accelerated program will remain on the undergraduate transcript, until the student is taken off of provisional acceptance and officially admitted as a fully accepted Cal U graduate student.

#### **Important Disclaimers:**

- 1. As part of the Accelerated program, student may apply up to 40% of the graduate program credits to satisfy the requirements of the undergraduate degree and the graduate degree. Accelerated students may register no more than 6 graduate credits in any one term, and in terms when a graduate course is registered, thestudent may not register for more than 18 total credits.
- 2. It is the student's responsibility to apply and meet the qualifications of the graduate program portion of your accelerated program.
- 3. Failure to follow through with enrollment in the accelerated graduate program will result in additional undergraduate credits to complete your Bachelor's degree as outlined in the Undergraduate Credit for Graduate Courses policy.
